

## The Skyline Brittany Club

The Skyline Brittany Club (SBC) was formed in 1955, held its first field trial in the spring of that year and has been continuously in existence since that time. The SBC is affiliated with the American Brittany Club (ABC), the only American Kennel Club (AKC) recognized Brittany parent club, and subscribes to the objective and purpose of the parent club, that is: "To promote cooperation and friendship among breeders and owners of Brittany's and to encourage higher standards in breeding, training and showing of Brittany's in the field and in the show ring; to discourage the breed from becoming split into groups of field dogs and show dogs and to strive to keep it forever a dual dog".

Membership is open to owners of one or more registered Brittany's and/or persons interested in the improvement of the breed. Annual membership is \$30.00 for a full membership. Membership entitles you to receive the American Brittany, a monthly magazine published by the American Brittany Club and The Skyline Byline, the bimonthly newsletter of the SBC. Full membership entitles all family members (parents and minor children to participate in all club activities. Full membership in the ABC is required for voting and to be an officer in the ABC or SBC.

General membership meetings are held bimonthly on the first Wednesday of each odd numbered month. Meetings are held at Micky's Top Sirloin, 6 E 70<sup>th</sup> Ave., Denver, CO 80221, Corner of 70<sup>th</sup> & Broadway, Just South of US36. We meet at 7:00 PM for diner and social hour, our business meeting follows at 7:30 PM. We invite you to join us at one of these meetings.

The SBC is a full service club offering AKC Licensed Field Trials in March, May (Walking) and September, AKC Licensed Hunt Tests in May and October, and two Specialty Shows in April and August, and an Awards Banquet in July to recognize the achievements of our dogs over the previous year. We do from time to time put on special training seminars and AKC Judges Seminars.
